Minutes of the Annual Business Meeting 17 May 1999 Hyatt Regency Hotel, Chicago

Present: Anne Maria Baxter, Billie Broaddus, Sally Brown, Patricia E. Gallagher, Stephen Greenberg, Heidi Heilemann, Nonnie Klein, Lucretia McClure, Diane McKenzie, Susan Marshall, Erich Meyerhoff, Richard Nolan, Frederic C. The meeting was called to order at 2:07pm by Stephen Greenberg, Acting Chair. (Maggie Yax resigned her office late last summer for personal reasons.) The minutes of the previous meeting were approved and the treasurer's report was read and accepted.

Election Results

Pat Gallagher reported that Heidi Heilemann is the Chair-Elect and Anne Maria Baxter is the Secretary/Treasurer. The slate was unanimously approved.

Continuing Education

Gallagher and Greenberg taught their half-day course, "Introduction to Reference Sources in the History of the Health Sciences," to twelve attendees at the joint MAC and Pittsburgh chapter meeting on 4 October 1998 and to nine attendees at the New York/New Jersey chapter meeting on 15 April 1999. A full day course on the history of the health sciences has been proposed for next year's annual meeting in Vancouver. Possibly a half-day course will be done for the College of Physicians in Philadelphia. Our Web site has gotten good notice and is easy to find via MLANET.

INCIPIT

Greenberg, who has been serving as interim editor, encouraged anyone interested in taking over the job to contact him. He recommended that the newsletter become more substantial and frequent. Whether we go electronic or not we will need to keep a paper version, especially for elections.

Program Committee

Barbara VanBrimmer reported that last year we had a number of joint programs; however, this year there was no interest in joint sessions so we did our own program. Twelve papers were submitted and four were chosen for presentation. Heidi Heilemann, who will be our next Program Chair, discussed the medical Societies and Relevant Issues sections as two possibilities for a joint program in 2000. Since next year's meeting is in Canada, customs requires any printed brochures brought in to state, "Printed in the USA" or the text must appear in both English and French. Perhaps we can offer an oral history program in lieu of our CE course which did not fill this year. If we did invited papers as opposed to contributed papers we could control the theme and content better. We will need to decide by the second week in June. Members were solicited for feedback on the earlier time slot this year for our program and business meetings. Reaction was very positive.

Section Council

Membership in MLA stands at 4900, of which 1100 are institutional members. A vice-chair will be elected for Section Council on Wednesday to fill the gap which occurs every third year between the chair and the in-coming chair. A new section, Corporate Information Services, and two new ZIGS, Internet and Voyager, have been proposed. The Mental Health Libraries section has been out of compliance for two years. If they decide to become a SIG, it has been proposed they be allowed to keep the funds remaining in their treasury with headquarters oversight. The single-slate-for-President proposal narrowly passed at the first business meeting and now must go to the membership for a vote.

Discussion is underway about a new name for MLA. "Medical" and "librarian" are thought by some to be limited. The restructuring of SC is proceeding as planned. The alternate will be eliminated; elections will be staggered so the incoming representative will act for the rep as necessary. A proxy vote can be exercised if neither is available. We need to elect our representative by 1 March 2000. This person will have a three year appointment - one as incoming and two as serving. In March 2001 we will need to select a representative elect. The McClure Excellence in Education Endowment has been created and a motion was made and seconded to donate \$500. It was passed with one abstention (McClure).

New Business

VanBrimmer will send out a personal letter to new members encouraging their participation; she also plans to put it on the Web page. She solicited ideas from those present for promoting more section interest. Heilemann will pursue a closed list-serve for our section once Stanford confirms it will be able to mount it on their server. This will be an automatic membership benefit and could change the content of INCIPIT since we do not want to duplicate. Diane McKenzie suggested an oral history column for the newsletter. The Gottlieb Award was given this year. We need to clarify if the winning paper is automatically published in the Bulletin.

Greenberg turned over the office to the incoming Chair and VanBrimmer adjourned the meeting at 3:38pm.

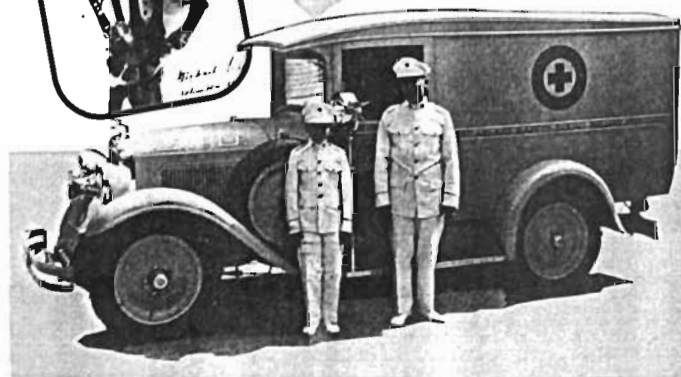
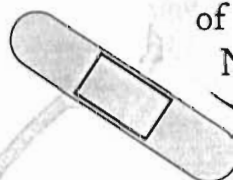

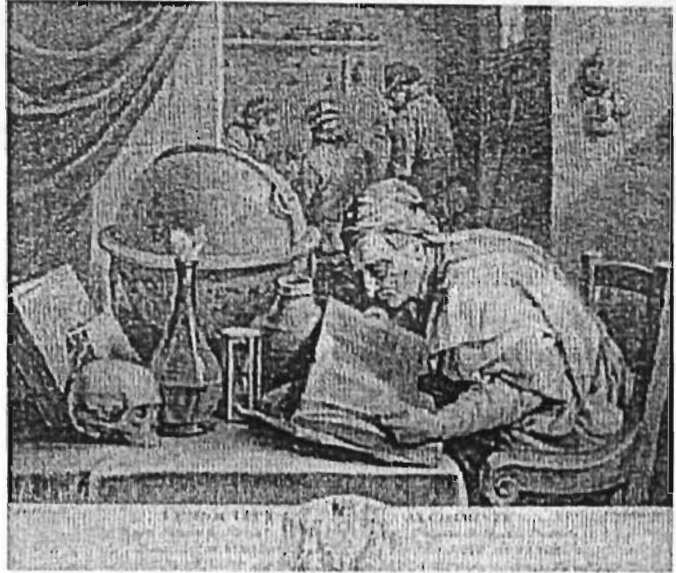
