Nominating Committee Report

The Nominating Committee held two elections this year. The election for the incoming Chair-Elect and Secretary/Treasurer concluded on December 1, 2010. **Susan U. Sanders** of the University of Mis-

souri – Kansas City was elected incoming Chair-Elect. **Deidra Woodson** of LSU Health Sciences Center – Shreveport was elected incoming Secretary/Treasurer.

ResearchRaven and ScanGrants

I would like to share with my fellow readers of *Incipit* two resources that I work on here at the Samaritan Health Services Center for Health Research and Quality that may assist them in their efforts to find funding for research in the history of the health sciences and in their hunt for places to publish and otherwise disseminate the results of their researches.

ResearchRaven <http://www.researchraven.com/> is a free online database of calls for papers for meetings and for publications in the health sciences. We include on ResearchRaven several categories that might be of interest to those who study the history of the health sciences: History, History of Nursing, History of Medicine, and History of Science (as well the related categories of Social Science, Medical Humanities, Literature and Medicine, and so on). I try to list on ResearchRaven whatever I come across on those topics.

All the categories on ResearchRaven can be subscribed to for free via email alerts or RSS. Many of the announcements on ResearchRaven can be seen on comparable discussion lists such as H-Sci-Med-Tech <http://www.h-net.org/~smt/>, but often I come across something that has not been listed on H-Sci-Med-Tech and not only do I send it there, I list it on ResearchRaven as well. Thus, I recommend that readers of *Incipit* follow both my own ResearchRaven and

H-Sci-Med-Tech for calls for papers.

And for those looking for funding such as fellowships, travel grants and the occasional essay award in the history of the health sciences, I would like to recommend the other resource I work on, ScanGrants <http://www.scangrants.com>, which includes the categories History of Medicine, History of Nursing, and History of Science. As we are all very well aware, only a few such funding opportunities are offered each year and I make a great effort to list whatever I find. I am gratified, now that ScanGrants has been around since 2008, to receive emails from those offering such opportunities asking me to list them on ScanGrants. I also both find such opportunities on H-Sci-Med-Tech and share what I find with that list.

I spend many hours on the Web and in my email account looking through the many lists I subscribe to via the H-Net network <http://www.h-net.org/>. Often I come across history of health sciences announcements in unexpected places (e.g., H-Asia <http://www.h-net.org/~asia>) with a call for papers on the history of medicine in East Asia or a conference announcement via Google about the concept of the monster in history where the organizers solicit papers from researchers in disability studies and in the history of medicine.

One of the goals, indeed, of ResearchRaven is to facilitate interdisciplinary synergies among those in the social sciences, humanities, and health sciences. It is fascinating, for instance, to see how such fictional characters as Sherlock Holmes and Dracula and the emerging concepts of transhumanism and posthumanism are being employed by those in the fields of popular culture and literary studies to illuminate how disease and its victims and outlier groups were portrayed compassionately or cruelly caricatured. It is such announcements as these that I list in the medical humanities and literature and medicine categories in ResearchRaven, and I recommend that historians of the health sciences consider subscribing (remember—doing so is free!) to those categories as well, given the valuable insights historians can offer to those in English studies, media/cultural studies, and related fields.

And do feel free to send me announcements of meetings and calls for papers to list on ResearchRaven or prizes, fellowships, stipends, etc. to list on ScanGrants. There are submission forms on both sites.

UT Southwestern Library Debuts Historical Photo Collection Online

The Library of the University of Texas Southwestern Medical Center has just debuted an online collection of 500+ historic photos documenting the development of medical care and medical education in Dallas. This online repository, titled **"Dallas Medical History, 1890-1975: A Digital Collection,"** is viewable on the web at <http://www4.utsouthwestern.edu/library/speccol/dmh/>

The Digital Collection consists of two complementary parts:

"Dallas Medical Images, 1890-1975": A repository of 500+ images from the Library's collection which portray institutions, people, and events that have played a role in Dallas medicine. Each photo is dated and accompanied by searchable descriptive information. About 200 of the images portray the history of UT Southwestern's predecessor institutions (e.g., Southwestern Medical College). Another 200 illustrate the history of St. Paul Hospital (now part of UT Southwestern) from 1896-1975—including many fascinating photos of the St. Paul interior and exterior around 1905—and the St. Paul School of Nursing from 1900-1971. The remaining 100 or so images document other institutions, people and events in Dallas medicine, including about 40 images of Parkland Memorial Hospital and the Parkland Hospital School of

Nursing, which operated from 1914 to 1955.

"Medical Care Milestones in Dallas, 1890-1975": An exhibit of 60 high-interest images, arranged in chronological order, showing highlights in the development of medical care in Dallas. Expanded descriptions explain the significance and context of the subject matter. Most of these images are also in the repository, but—to enrich the exhibit—thirteen have been added from the Dallas Public Library Texas/Dallas History and Archives collection and from other sources.

The CONTENTdm software used for the repository allows users to download images for use in PowerPoint presentations. The exhibit's OMEKA software allows users to share photos with others on Facebook.

Items within the **"Dallas Medical Images, 1890-1975"** repository and the **"Medical Milestones in Dallas, 1890-1975"** exhibit are provided by the Library for non-commercial, personal, or research use. For these purposes, materials may be reproduced (printed, photocopied, or downloaded) without prior permission. UIC Library of the Health Sciences Makes Collection of Paul De Kruif Letters Available

The UIC Library of the Health Sciences Special Collections Department has recently made available a collection of correspondence by **Paul De Kruif** (1890-1971), the bacteriologist, science writer, and advocate of polio research.

De Kruif, author of *Microbe Hunters* (1926) and numerous other books on aspects of medicine and health, was heavily involved in the promotion of polio research in the late 1930s. The close to 100 letters and over 70 telegrams in the collection consist of De Kruif's communications to Basil O'Connor, the chairman of the National Foundation for Infantile Paralysis (more widely known as the March of Dimes) and a close friend of Franklin Roosevelt.

The tireless De Kruif suggested research methods, made personnel recommendations, and offered financial and administrative advice to O'Connor.
